Assignment of Rights

The applicant assigns to the Jamaica Cultural Development Commission (JCDC) and the National Gallery of Jamaica (NGJ) the exclusive worldwide rights to make and commercially use photo images, audiovisual and sound recordings of the applicant's entry rendered in the course of this Competition & Exhibition. The assignment shall include the right to make and distribute mechanical audiovisual, sound and image carriers such as videos, DVD's, compact discs, brochures and catalogues as well as the rights to broadcast on radio, television and the World Wide Web.

Warranties

The applicant hereby warrants and represents that he/she is duly authorised to grant the rights abovementioned and hereby agrees to indemnify and hold the JCDC and the NGJ harmless from and against all claims that may arise from third parties as a consequence of the exercise of the rights granted to the JCDC and the NGJ. The applicant agrees to execute such other agreements as may be necessary to give effect to the undertakings herein mentioned.

Compensation to Applicant

In the event that the JCDC and the NGJ shall receive cash remuneration from the commercial use of a programme, recording or printed matter which includes the applicant's entry, the applicant shall be entitled to share equally with all applicants included in the programme, recording or printed matter, fifty percent (50%) of the net proceeds received by the JCDC and the NGJ. Net proceeds shall be determined after deduction of all recording, production, packaging, promotional and distribution costs.
